(Revenue \$) CHILDREN'S RESOURCE CENTER- ZAMBIA: THE CRC IS AN ORPHAN CARE CENTER DESIGNED TO SERVE AS A TRANSITIONAL RESIDENCE FOR CHILDREN FOUND LIVING IN CHILD HEADED HOUSEHOLDS OR ON THE STREETS. OUR PURPOSE IS TO ADDRESS THEIR PHYSICAL, SOCIAL, EMOTIONAL, AND EDUCATIONAL NEEDS, AND PROVIDE A LOVING ENVIRONMENT FOR THESE CHILDREN. IN MOST CASES THEY HAVE UNDERGONE TREMENDOUS LOSS AND ARE EXPERIENCING SERIOUS HEALTH PROBLEMS AS A RESULT OF MALNUTRITION AND NEGLECT.

DURING THE 2016/2017 FISCAL YEAR, WE CARED FOR 41 CHILDREN IN RESIDENCE; PROVIDING EDUCATION, FOOD, ALL HEALTH RELATED NEEDS INCLUDING HIV TREATMENT FOR 6 OF THE CHILDREN, GRIEF COUNSELING, ACCESS TO CARING ADULTS, SKILLS TRAINING AND RECREATION THERAPY.
