been brought in from situations of abuse, abandonment, trafficking, or the death of parents. While in our care, we focus on providing healthy family-centered relationships and encourage each child to discover a love for education and community service and to develop their hobbies and talents. Between July and December 2020, we cared for 59 children in residence providing education, food and all health-related needs; including HIV treatment, grief counseling, access to caring adults, skills training, and recreation therapy.

Education: On our Lusaka property, we operate a school-the Carol Zulu Primary School-for 518 children from the surrounding community. During 2020, we were unable to operate at full capacity due to the COVID-19 global pandemic and local public health policies. However, we continued education where possible, and ensured the continued support of our students through a relief feeding program-aiding the families of our students with food that was otherwise unavailable in the community. Our primary school is proud to have a 100% pass rate on the seventh grade national exam, where the national average is 65%. This school provides education through seventh grade, after which a number of our students continue on to our 17 to Self-Reliance program which provides higher education and vocational training sponsorships, as well as youth mentoring. During the shortened FYE 2020, there were 57 youth in this program, 15 of which were in foster care placements. These programs aim to support the dreams of each child and inspire hope for their futures as they transition to adulthood.

Sustainable Agriculture Project: To meet the growing needs of our programs and ensure continued programming during natural disasters and crises (such as drought or pandemic), we completed a sustainable, agricultural project during this period. Our goat project, expanded chicken co-op project, and duck raising project have increased our food production. Additionally, we irrigated an additional 21 acres and have hired a farm manager to oversee our expanded agricultural efforts. This project also provides the opportunity for vocational and skills training for the children living in our care. Additionally, this project has allowed us to employ 7 new Zambians to support the day-to-day operations of the project. During the shortened FYE 2020, we expanded our feeding programs to reach 5 new communities, providing food for communities who were experiencing severe famine due to pandemic and drought circumstances.

Additionally, we empowered 300+ women from the surrounding community in sewing and business skill training. We provided part or full time employment to 78 Zambians during the shortened FYE 2020 who run all programming in Zambia-providing income to the families of each of the 78 employees and ensuring our programs are led by local wisdom.
